## 1. Introduction

1. The support structure of the Executive Board of the clean development mechanism (CDM) (hereinafter referred to as the Board) consisting of: the Accreditation Panel (CDM-AP), the Methodologies Panel (MP), the Small-Scale Working Group (SSC WG), the Afforestation and Reforestation Working Group (A/R WG) and the Carbon Dioxide Capture and Storage Working Group (CCS WG) is established under the Board to assist in the performance of its functions related to the accreditation system (CDM-AP) and methodological issues concerning CDM project activities (MP, SSC WG, A/R WG and CCS WG). The mandates of the panels and working groups are determined by their terms of reference, the rules of procedure of the Board, and additional guidance provided by the Board.
2. This workplan of the panels and working groups for 2016 outlines the expected tasks to support the Board and has been developed within the context of the CDM management plan 2016. The workplan includes the routine operation activities to be performed by the panels and working groups as well as mandates provided by the Board.
