**SECTION 3: COMMENTS SUPPORTING REVIEW REQUEST**

*Please elaborate the reason for requesting a review on the issues you indicated in section 2 above*

1) The DOE is requested how it assessed the conversion factor of 7.14 kg wood per kg charcoal from study "Wood fuel consumption in Maputo, Mozambique" published in 2004, for the calculation of parameter Bold (Quantity of woody biomass used in the absence of the project activity in tonnes of wood), as: (i) it remains unclear how the study for city of Maputo is applicable for a CPA in city of Pemba and how the DOE concluded that the production procedures of charcoal are similar all over the country; (ii) the study "Mozambique Biomass Energy Strategy" (2012) used by DOE/CME to support the use of conversion factor 7.14, in section 4.7.1.4 mentions that out of one ton of wood only 150 kg of charcoal is recuperated, representing a conversion factor of 6.67 kg wood per kg charcoal, and is more recent than the study used by CPA 9981-0003.
