一、该项目规划方案及其第一个规划活动符合《清洁发展机制项目运行管理办法(修订)》规定的许可条件,符合我国实现可持续发展的战略目标,同意作为规划类清洁发展机制项目。



二、授权你公司作为中方的协调/管理机构开展项目活动。

三、同意你公司向 UPM 环境项目管理有限公司转让该规划方案的第一个规划活动(活动名称:CPA SCAFBG-2011-01(四川养殖场沼气工程规划类清洁发展机制项目))产生的温室气体减排量,转让总量不超过6万吨二氧化碳当量(其中包括2013年1月1日至该项目第一计入期末产生的5万吨二氧化碳当量),每吨二氧化碳当量转让价格不低于9欧元。其它后续规划活动及转让总量需另行批准。


### Letter of Approval for Sichuan Animal Farms GHG Mitigation Programme by National Development and Reform Commission of the People's Republic of China

No. 3766

The Chinese Government approves Sichuan Animal Farms GHG Mitigation Programme as a Clean Development Mechanism Programme of Activities (CDM PoA), with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The PoA and the 1<sup>st</sup> CDM Programme Activity (CPA) of Sichuan Animal Farms GHG Mitigation Programme comply with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China (Modified), and assists China in achieving sustainable development.
3. Chendu Oasis Science & Technology Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the PoA as the Coordinating/Managing Entity.
4. Chendu Oasis Science & Technology Co., Ltd. is permitted to transfer to UPM Umwelt-Projekt-Management GmbH which is authorized by the Government of the United Kingdom no more than 60,000tCO<sub>2</sub>e Certified Emission Reductions (CERs) in total to be generated from the 1<sup>st</sup> CPA (Title: Sichuan Animal Farms GHG Mitigation Programme, CPA Nb. SCAFBG-2011-01) of the PoA. Other CPAs and the transfer of emission reductions from them should be approved separately.
