
Letter of Approval for Hebei Animal Manure Management System (AMMS) GHG Mitigation Programme by National Development and Reform Commission of the People's Republic of China

No. 3897

The Chinese Government approves Hebei Animal Manure Management System (AMMS) GHG Mitigation Programme as a Clean Development Mechanism Programme of Activities (CDM PoA), with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The PoA and the 1st CDM Programme Activity (CPA) of Hebei Animal Manure Management System (AMMS) GHG Mitigation Programme comply with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assist China in achieving sustainable development.
3. Hebei Green Agriculture Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the PoA as the Coordinating/Managing Entity.
4. Hebei Green Agriculture Co., Ltd. is permitted to transfer all CERs be generated from the 1st CPA (Title: Hebei Animal Manure Management System (AMMS) GHG Mitigation Programme---CPA No.001) of the PoA into China's national account in the CDM registry, and these CERs can only be transferred to other account if the buyer is determined, with the consent of China's Designated National Authority for CDM. Other CPAs and the transfer of emission reductions from them should be approved separately.
