
Letter of Approval for CFL Distribution Programme in Shaanxi Province by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves CFL Distribution Programme in Shaanxi Province as a Clean Development Mechanism Programme of Activities (CDM PoA), with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The PoA and the 1st CDM Programme Activity (CPA) of CFL Distribution Programme in Shaanxi Province comply with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assist China in achieving sustainable development.
3. Carbon Gold Beijing Technology Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the PoA as the Coordinating/Managing Entity.
4. Carbon Gold Beijing Technology Co., Ltd. is permitted to transfer all CERs be generated from the 1st CPA (Title: "CFL Distribution Programme in Shaanxi Province"CAP1) of the PoA into China's national account in the CDM registry, and these CERs can only be transferred to other account if the buyer is determined, with the consent of China's Designated National Authority for CDM. Other CPAs and the transfer of emission reductions from them should be approved separately.
