你公司报来的拟与 A&T 碳资产有限公司进行规划类清洁发展机制项目合作(项目名称:河南省和陕西省养殖场粪便处理规划项目)的申请及相关文件收悉。根据《清洁发展机制项目运行管理办法(修订)》的规定,经国家清洁发展机制项目审核理事会审核,现就你公司与 A&T 碳资产有限公司进行规划类清洁发展机制项目合作批复如下:

一、该项目规划方案及其第一个规划活动符合《清洁发展机制项目运行管理办法(修订)》规定的许可条件,符合我国实现可持续发展的战略目标,同意作为规划类清洁发展机制项目。

二、授权你公司作为中方的协调/管理机构开展项目活动。

三、同意你公司向 A&T 碳资产有限公司转让该规划方案的第一个规划活动(活动名称:河南省和陕西省养殖场粪便处理规划项目—CPA-0001)产生的温室气体减排量,转让总量不超过 5 千吨二氧化碳当量,每吨二氧化碳当量转让价格不低于 8 欧元。其它后续规划活动及转让总量需另行批准。

四、请你公司根据专家意见对项目设计文件做进一步的修订与完善,以利于项目的顺利开展。


Letter of Approval for Animal Manure Treatment Programme in Henan Province and Shaanxi Province by National Development and Reform Commission of the People's Republic of China

No. 4256

The Chinese Government approves Animal Manure Treatment Programme in Henan Province and Shaanxi Province as a Clean Development Mechanism Programme of Activities (CDM PoA), with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The PoA and the 1st CDM Programme Activity (CPA) of Animal Manure Treatment Programme in Henan Province and Shaanxi Province comply with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China (Modified), and assists China in achieving sustainable development.
3. Zhongruihe International New Energy Science and Technology (Beijing) Co. Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the PoA as the Coordinating/Managing Entity.
4. Zhongruihe International New Energy Science and Technology (Beijing) Co. Ltd. is permitted to transfer to A&T Carbon Asset Co., Limited which is authorized by the Government of the United Kingdom no more than 5,000tCO₂e Certified Emission Reductions (CERs) in total to be generated from the 1st CPA (Title: Animal Manure Treatment Programme in Henan Province and Shaanxi Province--CPA - 0001) of the PoA. Other CPAs and the transfer of emission reductions from them should be approved separately.
