你公司报来的拟与碳资产管理株式会社进行规划类清洁发展机制项目合作（项目名称：陕西彬长煤矿通风瓦斯氧化规划类项目）的申请及相关文件收悉。根据《清洁发展机制项目运行管理办法（修订）》的规定，经国家清洁发展机制项目审核理事会审核，现就你公司与碳资产管理株式会社进行规划类清洁发展机制项目合作批复如下：

一、该项目规划方案及其第一个规划活动符合《清洁发展机制项目运行管理办法（修订）》规定的许可条件，符合我国实现可持续发展的战略目标，同意作为规划类清洁发展机制项目。

二、授权你公司作为中方的协调/管理机构开展项目活动。

三、同意你公司向碳资本管理株式会社转让该规划方案的第一个规划活动(活动名称:大佛寺煤矿通风瓦斯氧化项目(CPA-CVAM-1))产生的温室气体减排量,转让总量不超过240万吨二氧化碳当量(其中包括2013年1月1日之后产生的206万吨二氧化碳当量),每吨二氧化碳当量转让价格不低于9欧元。

四、请你公司根据专家意见对项目设计文件做进一步的修订与完善,以利于项目的顺利开展。


Letter of Approval for China Coal Mine Ventilation Air Methane Oxidization Programme by National Development and Reform Commission of the People's Republic of China

No. 3396

The Chinese Government approves China Coal Mine Ventilation Air Methane Oxidization Programme as a Clean Development Mechanism Programme of Activities (CDM PoA), with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The PoA and 1st CDM Programme Activity (CPA) of China Coal Mine Ventilation Air Methane Oxidization Programme comply with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Shaanxi Binchang New Energy Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the PoA as the Coordinating/Managing Entity.
4. Shaanxi Binchang New Energy Co., Ltd. is permitted to transfer to Carbon Capital Management, Inc. which is authorized by the Government of Japan no more than 2,400,000tCO₂e Certified Emission Reductions (CERs) in total to be generated from the 1st CPA (Title: Dafosi Coal Mine Ventilation Air Methane Power Generation Project (CPA-CVAM-1)) of the PoA. Other CPAs and the transfer of emission reductions from them should be approved separately.
