



## Written Approval

To whom it may concern,

The State of the Netherlands, acting through the Netherlands' Ministry of Infrastructure and the Environment ("**IenM**"), being the national authority for the Clean Development Mechanism (CDM), hereby declares that:

- (i) the State of the Netherlands ratified the Kyoto Protocol on 31 May 2002;
- (ii) the State of the Netherlands participates voluntarily in the below stated "**CDM Project Activities**";
- (iii) the State of the Netherlands, as a Party directly involved in the below stated "**CDM Project Activities**" authorizes the participation of the Netherlands' Ministry of Infrastructure and the Environment ("**IenM**") as a Project Participant in the below stated "**CDM Project Activities**" and wishes to receive Certified Emission Reductions ("**CERs**") in the national registry account: NL-100-8-0 "Netherlands CDM Purchase Programme";
- (iv) the State of the Netherlands hereby also authorizes the participation of the International Finance Corporation, in its individual capacity and as Trustee of the "IFC-Netherlands Carbon Facility" as a Project Participant in the below stated "**CDM Project Activities**";
- (v) this Written Approval covers the requirements of paragraphs 33 and 40 (a) and (f) of the CDM Modalities and Procedures.

Finally, the State of the Netherlands declares that for the purchase of CERs resulting from the below stated "**CDM Project Activities**", public funding of the State of the Netherlands is involved. It confirms that this public funding does not result in a diversion of official development assistance and is separate from and not counted towards the financial obligations of the State of the Netherlands in that respect.



## Letter of Authorization

Pursuant to the IFC-Netherlands CDM Operating Agreement dated 17 January 2002 (Agreement) between the State of the Netherlands (the Netherlands), acting through the Ministry of Housing, Spatial Planning and the Environment (VROM) and the International Finance Corporation acting in its individual capacity (IFC) and as trustee (Trustee), establishing the IFC-Netherlands Carbon Facility (INCaF), through which the IFC assists VROM in acquiring Emission Reductions generated by CDM Project activities:

The IFC is authorized to negotiate and sign Emission Reductions Purchase Agreements (ERPAs) with project companies for the benefit of VROM. ERPAs entered into by the IFC as Trustee shall provide for Emission Reductions to be transferred or issued to the order of VROM.

Bearing in mind the aforementioned I herewith state:

That the Netherlands authorizes the IFC, in its individual capacity and as Trustee pursuant to the Agreement, to participate for the benefit of the Netherlands in the CDM project activity "Hapugastenne and Hulu Ganga Small Hydropower Projects in Sri Lanka" ('Project') as a Project Participant; and.

That for the purpose of the Project Design Document (PDD-CDM) for the Project the following should be listed as a "Project Participant": the Netherlands represented by its Ministry of Housing, Spatial Planning and the Environment acting through the International Finance Corporation, in its individual capacity and as Trustee of the IFC-Netherlands Carbon Facility (INCaF).
