

- (iii) M/s ROARING 40s WIND FARMS (KHANDAKE) PRIVATE LIMITED shall furnish expeditiously any information, during the lifetime of the project as requested by the National CDM Authority.
- (iv) M/s ROARING 40s WIND FARMS (KHANDAKE) PRIVATE LIMITED shall obtain all statutory clearances and other approvals as required from the competent authorities for setting up of the project.
- (v) All transactions shall be subject to supervision of the Executive Board of the CDM, under the authority and guidance of the COP/MOP.
