

2. Yicheng Biomass Cogeneration Project in Hubei Province, China complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Anneng (Yicheng) Biomass Thermo-Electricity Co. Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Anneng (Yicheng) Biomass Thermo-Electricity Co. Ltd. is permitted to transfer to Emission Shandels Gesellschaft Bavaria GmbH which is authorized by the Government of Germany no more than 730,000 tCO₂e in total Certified Emission Reductions (CERs).
