

3. Wuhe Kaidi Green Energy Development Co.,Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Wuhe Kaidi Green Energy Development Co.,Ltd is permitted to transfer to Camco International Limited which is authorized by the Government of the United Kingdom no more than 560,000 tCO₂e in total Certified Emission Reductions (CERs).
