
### Letter of Approval for Hunan Xiaotan Hydropower Project As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Hunan Xiaotan Hydropower Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Hunan Xiaotan Hydropower Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Chenxi County Qiongtian Hydropower Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Chenxi County Qiongtian Hydropower Co., Ltd. is permitted to transfer to One Carbon International BV that is authorized by the Government of Netherlands no more than 320,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
