
### Letter of Approval for Coke oven gas comprehensive utilization for co-generation project in Shandong Jikuang Morningsun Thermal Power Co., Ltd by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Coke oven gas comprehensive utilization for co-generation project in Shandong Jikuang Morningsun Thermal Power Co., Ltd as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Coke oven gas comprehensive utilization for co-generation project in Shandong Jikuang Morningsun Thermal Power Co., Ltd complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Shandong Jikuang Morningsun Thermal Power Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Shandong Jikuang Morningsun Thermal Power Co., Ltd is permitted to transfer to Lakewood Carbon Corp. which is authorized by the Government of the United Kingdom no more than 320,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
