

2. Tongcheng Kaidi Biomass Power Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Tongcheng Kaidi Green Energy Development Co.,Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Tongcheng Kaidi Green Energy Development Co.,Ltd is permitted to transfer to Camco International Limited which is authorized by the Government of the U.K. no more than 610,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
