
Letter of Approval for Qichun Kaidi Biomass Power Project As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

3. Qichun Kaidi Green Energy Development Co.,Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Qichun Kaidi Green Energy Development Co.,Ltd is permitted to transfer to Camco International Limited which is authorized by the Government of the United Kingdom no more than 670,000 tCO₂e in total Certified Emission Reductions (CERs).
