

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Shenyang Laohuchong LFG Power Generation Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Shenyang Laohuchong Municipal Solid Waste Management Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Shenyang Laohuchong Municipal Solid Waste Management Co., Ltd. is permitted to transfer to Asja Ambiente Italia S.p.A. that is authorized by the Government of Italy no more than 500,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
