
Sir,

- (ii) M/s Punjab Hydro Power Private Limited and the other project developers shall inform the National CDM Authority regarding all transaction details of CERs including the name and address of the party to which CERs were sold within 30 days of transfer of the CERs.
- (iii) M/s Punjab Hydro Power Private Limited and the other project developers shall furnish expeditiously any information, during the lifetime of the project as requested by the National CDM Authority.
- (iv) M/s Punjab Hydro Power Private Limited and the other project developers shall obtain all statutory clearances and other approvals as required from the competent authorities for setting up of the project.
- (v) All transactions shall be subject to supervision of the Executive Board of the CDM, under the authority and guidance of the COP/MOP.
- (vi) This approval is not transferable. The authority reserves the right to revoke this Host Country Approval if the conditions stipulated in this approval are not complied with to the satisfaction of the National CDM Authority.

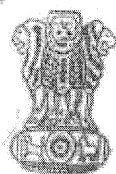
