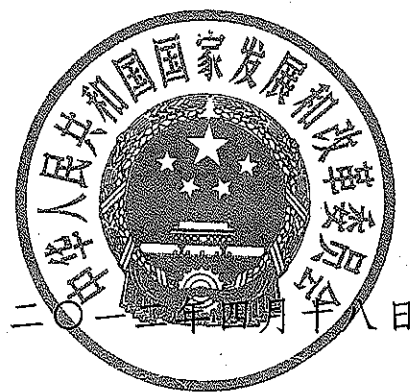
二、授权你公司作为中方的实施机构开展项目活动。


### Letter of Approval for Jiangxi Xiajiang Hydropower Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Jiangxi Xiajiang Hydropower Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Jiangxi Xiajiang Hydropower Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China (Modified), and assists China in achieving sustainable development.
3. Jiangxi CPI Xiajiang Power Generation Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Jiangxi CPI Xiajiang Power Generation Co., Ltd. is permitted to transfer to J-TEC Co., Ltd. which is authorized by the Government of Japan no more than 5,390,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
