

4. China Water Group Huade Wind Power Co., Ltd. is permitted to transfer to Eco-Tec Asia(UK) Ltd. which is authorized by the Government of the United Kingdom no more than 930,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
