
### Letter of Approval for Heqing Solar Cooker Project II by National Development and Reform Commission of the People's Republic of China

3. Beijing Harmonious Energy Development Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Beijing Harmonious Energy Development Co., Ltd. is permitted to transfer to Clean Air Capital Ltd which is authorized by the Government of the Netherlands no more than 200,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
