
### Letter of Approval for Wangjiang Kaidi Biomass Power Project by National Development and Reform Commission of the People's Republic of China

4. Wangjiang Kaidi Green Energy Development Co., Ltd. is permitted to transfer to Camco International Limited which is authorized by the Government of the United Kingdom no more than 550,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
