
Letter of Approval for Liujiashan 10 MW Small Hydropower Project in Jiangxi Province As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves the Liujiashan 10 MW Small Hydropower Project in Jiangxi Province as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The Liujiashan 10 MW Small Hydropower Project in Jiangxi Province complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Zixi Sanjiang Hydropower Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Zixi Sanjiang Hydropower Co., Ltd is permitted to transfer to EcoSecurities Group PLC that is authorized by the Government of the United Kingdom no more than 150,000 tCO₂e in total Certified Emission Reductions (CERs).
