
Letter of Approval for Shenmu County Hengsheng Coal Chemical Co., Ltd.

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Shenmu County Hengsheng Coal Chemical Co., Ltd. 30MW Semi-coke Waste Gas Power Generation Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Shenmu County Hengsheng Coal Chemical Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Shenmu County Hengsheng Coal Chemical Co., Ltd. is permitted to transfer to Endesa Carbone S.L. which is authorized by the Government of Spain no more than 280,000tCO₂e in total Certified Emission Reductions (CERs).
