
### Letter of Approval for Yuecheng Coal Mine Methane Power Generation Project by National Development and Reform Commission of the People's Republic of China

3. Jincheng Runhong New Energy Power Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Jincheng Runhong New Energy Power Co., Ltd is permitted to transfer to Originate Carbon Ltd which is authorized by the Government of the United Kingdom no more than 260,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
