
### Letter of Approval for Fuqing MSW Incineration Project by National Development and Reform Commission of the People's Republic of China

4. C&G Environmental Protection (Fuqing) Co., Ltd. is permitted to transfer to Fine Carbon Fund Ky, Nordic Carbon Fund Ky, GreenStream Network Plc and Fine Post-2012 Carbon Fund Ky which are authorized by the Government of Finland no more than 1,310,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
