3. Jingyuan Coal Group Baiyin Jieneng Thermoelectricity Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Jingyuan Coal Group Baiyin Jieneng Thermoelectricity Co., Ltd. is permitted to transfer to Gazprom Marketing & Trading Singapore Pte. Ltd. which is authorized by the Government of the United Kingdom no more than 370,000tCO₂e in total Certified Emission Reductions (CERs).
