

3. Jidong Cement Panshi Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Jidong Cement Panshi Co., Ltd. is permitted to transfer to Climate Change Capital Carbon Managed Account Limited and Climate Change Capital Carbon Fund II s.a.r.l. which are both authorized by the Government of the United Kingdom no more than 430,000 tCO₂e in total Certified Emission Reductions (CERs).
