
Letter of Approval for Heilongjiang Yilan Hezuolinchang Phase II Wind Power Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Heilongjiang Yilan Hezuolinchang Phase II Wind Power Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Heilongjiang Yilan Hezuolinchang Phase II Wind Power Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Yilan Longyuan Wind Power Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Yilan Longyuan Wind Power Co., Ltd. is permitted to transfer to Essent Trading International S.A. which is authorized by the Government of Switzerland no more than 240,000 tCO₂e in total Certified Emission Reductions (CERs).
