

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Liaoning Changtu Quantou Wind Power Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Tieling Longyuan Wind Power Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Tieling Longyuan Wind Power Co., Ltd. is permitted to transfer to Kommunalkredit Public Consulting GmbH that is authorized by the Government of Austria no more than 600,000 tCO₂e in total Certified Emission Reductions (CERs).
