
### Letter of Approval for Guangdong Pinghai Power Plant Phase I Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Guangdong Pinghai Power Plant Phase I Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Guangdong Pinghai Power Plant Phase I Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Guangdong Huizhou Pinghai Power Station Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Guangdong Huizhou Pinghai Power Station Co., Ltd. is permitted to transfer to EcoSecurities International Limited which is authorized by the Government of the United Kingdom no more than 2,000,000tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
