
### Letter of Approval for Sichuan Lengshuikou 12.1MW Small-Scale Bundled Hydropower Project As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Sichuan Lengshuikou 12.1MW Small-Scale Bundled Hydropower Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Sichuan Lengshuikou 12.1MW Small-Scale Bundled Hydropower Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Sichuan Mabian Tianhe Power Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Sichuan Mabian Tianhe Power Co., Ltd. is permitted to transfer to CEZ a.s. which is authorized by the Government of Czech Republic no more than 190,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
