
Letter of Approval for Hebei Chengde Yudaokou Windfarm 48MW project As a

2. Hebei Chengde Yudaokou Windfarm 48MW project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. China Resources Wind Power (Chengde) Co., LTD. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. China Resources Wind Power (Chengde) Co., LTD. is permitted to transfer to Vitol S.A which is authorized by the Government of Switzerland no more than 450,000 tCO₂e in total Certified Emission Reductions (CERs).
