

The Chinese Government approves Shuanghekou 16.6MW Hydropower Project in Chongqing City, P.R. China as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Shuanghekou 16.6MW Hydropower Project in Chongqing City, P.R. China complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Kai County Dongli River Hydropower Co. Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Kai County Dongli River Hydropower Co. Ltd. is permitted to transfer to Marubeni Corporation which is authorized by the Government of Japan no more than 280,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
