

3. Liupanshui Tuoyuan Group Co. Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Liupanshui Tuoyuan Group Co. Ltd. is Permitted to transfer to Eco Asset Inc. which is authorized by the Government of Japan no more than 210,000 tCO₂e in total Certified Emission Reductions(CERs).
