

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Yunnan Province, Tengchong County, XiShanHe Hydropower Station Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Tengchong County Qinghe Hydropower Development Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Tengchong County Qinghe Hydropower Development Co., Ltd. is permitted to transfer to Asja Ambiente Italia S.p.A that is authorized by the Government of Italy no more than 150,000 tCO₂e in total Certified Emission Reductions (CERs).
