
Letter of Approval for Hunan Tongdao Yaolaitan 5.55MW Hydro Power Project by National Development and Reform Commission of the People's Republic of China

2. Hunan Tongdao Yaolaitan 5.55MW Hydro Power Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Tongdao Yaolaitan Hydro Power Development Co.,Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Tongdao Yaolaitan Hydro Power Development Co.,Ltd. is permitted to transfer to Climate Bridge Ltd. which is authorized by the Government of the United Kingdom no more than 80,000tCO₂e in total Certified Emission Reductions (CERs).
