

The Chinese Government approves the Inner Mongolia Keshiketeng County Wutaohai South Wind Farm 49.5 MW Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The Inner Mongolia Keshiketeng County Wutaohai South Wind Farm 49.5 MW Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Keshiketeng County Huifeng New Energy Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Keshiketeng County Huifeng New Energy Co., Ltd is permitted to transfer to New Energy and Industrial Technology Development Organization that is authorized by the Government of Japan no more than 700,000 tCO₂e in total Certified Emission Reductions (CERs).
