
Letter of Approval for Energy efficiency improvements of Pucheng Power Plant through retrofitting turbines in China by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Energy efficiency improvements of Pucheng Power Plant through retrofitting turbines in China as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Energy efficiency improvements of Pucheng Power Plant through retrofitting turbines in China complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Shaanxi Huadian Pucheng Power Generation Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Shaanxi Huadian Pucheng Power Generation Co., Ltd. is permitted to transfer to Kyushu Electric Power Co., Inc. which is authorized by the Government of Japan no more than 660,000tCO₂e in total Certified Emission Reductions (CERs).
