

The Chinese Government approves Heilongjiang Yilan Jiguanlazishan Wind Farm Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Heilongjiang Yilan Jiguanlazishan Wind Farm Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Harbin Yilan Huafu Wind Power Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Harbin Yilan Huafu Wind Power Co., Ltd. is permitted to transfer to Goldman Sachs International which is authorized by the Government of the United Kingdom no more than 540,000 tCO₂e in total Certified Emission Reductions (CERs).
