
Letter of Approval for Jiangsu Jiaoqiao Cement Plant's Low Temperature Waste Heat Power Generation Project As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Jiangsu Jiaoqiao Cement Plant's Low Temperature Waste Heat Power Generation Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Jiangsu Jiaoqiao Cement Plant's Low Temperature Waste Heat Power Generation Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Jiangsu Jiaoqiao Cement Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Jiangsu Jiaoqiao Cement Co., Ltd is permitted to transfer to Marubeni Corporation that is authorized by the Government of Japan no more than 130,000 tCO₂e in total Certified Emission Reductions (CERs).
