

2. Jiangxi Fengcheng CMM Distribution Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Fengcheng Pipeline Gas Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Fengcheng Pipeline Gas Co., Ltd is permitted to transfer to CEZ a.s. which is authorized by the Government of Czech Republic no more than 570,000 tCO₂e in total Certified Emission Reductions (CERs).
