


本协议一式四份，甲乙双方各执两份，具有同等法律效力。

Cooperation Agreement on Clean Development Mechanism Revenue Application

Party A: Fugong Hongyuan Hydropower Development Co., Ltd.

Party B: The Power Enterprises Association of Dehong Prefecture

This agreement is entered into and performed by Party A and Party B through friendly negotiation with good faith and in the spirit of mutual benefits, fairness and honesty.

Whereas Interim Measures for Operation and Management of Clean Development Mechanism Project was issued by National Development and Reform Commission of China on June 30th, 2004, Party A is the project owner of Yunnan Nujiang Fugong Guquan River Hydropower Station ("Party a project"), and Party B will assist Party A for the application of CDM revenue.

This agreement shall be in effect after mutual signatures. An amendment agreement shall be signed for any further issues.

Any dispute arisen from, come out of or in connection with this agreement, shall be solved by both parties through negotiation with good faith, or otherwise by attribution in mutual appointed attribution organization. Each party shall burden half of the attribution cost.

The agreement shall be executed in 4 original copies, and each party keeps two.
