

2. Tangshan Xinfeng Thermal & Power Co., Ltd. Waste Gas Power Generation Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Tangshan Xinfeng Thermal & Power Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Tangshan Xinfeng Thermal & Power Co., Ltd. is permitted to transfer to Climate Change Capital Carbon Fund II S.à r.l. and Climate Change Capital Carbon Managed Account Limited that are authorized by the Government of the United Kingdom no more than 1,680,000 tCO<sub>2</sub>e and 270,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs) respectively.
