

The Chinese Government approves Hejiang County Yuanxing Hydro Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Hejiang County Yuanxing Hydro Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Luzhou Jiale Yuanxing Power Development Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Luzhou Jiale Yuanxing Power Development Co., Ltd. is permitted to transfer to EcoSecurities Group plc that is authorized by the Government of the United Kingdom no more than 350,000 tCO₂e in total Certified Emission Reductions (CERs).
