
Letter of Approval for Tianjin Zhenxing Cement Waste Heat Recovery for Power Generation Project As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Tianjin Zhenxing Cement Waste Heat Recovery for Power Generation Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Tianjin Zhenxing Cement Waste Heat Recovery for Power Generation Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Tianjin Zhenxing Cement Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Tianjin Zhenxing Cement Co., Ltd is permitted to transfer to Arreon Carbon UK Ltd. as well as Credit Suisse International which are both authorized by the Government of the United Kingdom no more than 130,000 tCO₂e respectively in total Certified Emission Reductions (CERs).
