

The Chinese Government approves Zilenghe 24 MW Hydropower Project in Yunnan Province as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Zilenghe 24 MW Hydropower Project in Yunnan Province complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Fugong Hengda Hydropower Development Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Fugong Hengda Hydropower Development Co., Ltd. is permitted to transfer to Carbon Asset Management Sweden AB that is authorized by the Government of Sweden no more than 450,000 tCO₂e in total Certified Emission Reductions (CERs).
