

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Power Generation from Coking Waste Heat Utilization Project at Qinyuan County Mingyuan Coal and Coke Co., Ltd complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Qinyuan County Mingyuan Coal and Coke Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Qinyuan County Mingyuan Coal and Coke Co., Ltd. is permitted to transfer to Trading Emissions PLC that is authorized by the Government of the United Kingdom no more than 900,000 tCO₂e in total Certified Emission Reductions (CERs).
