
Letter of Approval for Shaanxi Haiyan Coke Making Group 24MW Waste Coke Oven Gas (COG) Based Electricity Generation Plant by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Shaanxi Haiyan Coke Making Group 24MW Waste Coke Oven Gas (COG) Based Electricity Generation Plant as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Shaanxi Haiyan Coke Making Group 24MW Waste Coke Oven Gas (COG) Based Electricity Generation Plant complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Shaanxi Haiyan Coke Making(Group) Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Shaanxi Haiyan Coke Making(Group) Co., Ltd. is permitted to transfer to Tepia Corporation Japan Co., Ltd. which is authorized by the Government of the Japan no more than 520,000tCO₂e in total Certified Emission Reductions (CERs).
