
Letter of Approval for Hebei Shangyi Manjing North Wind Farm Project As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

The Chinese Government approves Hebei Shangyi Manjing North Wind Farm Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. Hebei Shangyi Manjing North Wind Farm Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Guohua (Hebei) Renewable Energy Co., Ltd. is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Guohua (Hebei) Renewable Energy Co., Ltd. is permitted to transfer to Carbon Resource Management Ltd. which is authorized by the Government of the United Kingdom no more than 500,000 tCO₂e in total Certified Emission Reductions (CERs).
