

4. Taiyuan Gangyuan Coking & Chemicals Co., Ltd. is permitted to transfer to Trading Emissions PLC that is authorized by the Government of the United Kingdom no more than 1,000,000 tCO<sub>2</sub>e in total Certified Emission Reductions (CERs).
